**The terms and condition for the supply of stores are as follows:**

1. The materials will have to be supplied within the period of 30 days from the date of placing of the supply order.
2. The GST and any other levy applicable at the time of supply may be shown separately in the quotation; otherwise it will be presumed that the prices offered as inclusive of all the taxes whatever may be.
3. The rates quoted shall be inclusive of packing and forwarding charges and freight paid for destination I.T.I. Bogda, Vasco-de-Gama, Goa.
4. The printed terms and conditions in your quotation will not be binding unless specifically referred to in the covering letter.
5. The instructional operating manual shall be furnished along with the equipment as the case may be.
6. The quotation shall be valid for 90 days from the date of opening of the same.
7. The stores will be inspecting for accepting and will be accepted if it conforms to the specification mentioned in the supply order. (The stores can be inspected in yours presence or in the presence of your representative).
8. In case of rejection of the stores for not conforming to specification in the supply order. The same will be sole responsibility of the supplier to make arrangement to collect the same at his own cost and risk immediately.
9. The coast of installation, commencing and demonstration if any shall be mentioned separately along the defect for the period of 12 months from the date of acceptance.
10. The tools & equipments supplied as the case may be should carry a warranty/ guarantee against the defect for the period of 12 months from the date of acceptance.
11. In case the payment is desired outside the state be a Demand Draft, the bank commission shall have to be borne by the supplier.
12. In the event of any disputes arising out in this connection it shall be subjected to the jurisdiction at Panaji- Goa.
13. This office reserves the right to accept or reject any or all the quotation without assigning any reason thereof.
14. This office reserves the right to place order for part/full quantity mentioned in the quotation for the purpose of the stores as the case may be.
