- **5**. The instructional operating manual shall be furnished along with the equipment as the case may be.

- **7**. The stores will be inspecting for accepting and will be accepted if it conforms to the specification mentioned in the supply order. (The stores can be inspected in yours presence or in the presence of your representative).
- **3**. In case of rejection of the stores for not conforming to specification in the supply order. The same will be sole responsibility of the supplier to make arrangement to collect the same at his own cost and risk immediately.
- 2. The coast of installation, commencing and demonstration if any shall be mentioned separately along the defect for the period of 12 months from the date of acceptance.
- **25.** The tools & equipments supplied as the case may be should carry a warranty/ guarantee against the defect for the period of 12 months from the date of acceptance.
- 14. In case the payment is desired outside the state be a Demand Draft, the bank commission shall have to be borne by the supplier.
